

Consulting Services Agreement

This Consulting Agreement states the terms and conditions that govern the contractual agreement between Ward Systems Group, Inc. and the Client who agrees to be bound by this Agreement.

Whereas, Ward Systems Group, Inc. offers consulting services; and

Whereas, the Client desires to retain the services of Ward Systems Group, Inc. to render consulting services according to the terms and conditions herein.

Now, therefore, In consideration of the mutual covenants and promises made by the parties hereto, the Consultant and the Client covenant and agree as follows:

Consulting Services

Ward Systems Group, Inc. agrees that it shall provide its expertise to the Client for all things pertaining to the “Consulting Services” as described below:

- One-on-one teaching lessons on how to use NeuroShell Trader via remote desktop sharing.
- Advice and assistance on building trading systems in NeuroShell Trader.
- Programming of custom indicators and trading systems of the Client's specification within NeuroShell Trader.
- Optimizing Client's NeuroShell Trader charts for faster calculation and optimization times.

Compensation

In consideration for the Consulting Services, the Client shall pay Ward Systems Group, Inc at the rate of \$150 per hour. All Consulting Services must be purchased in advance and bought in increments of one hour. Consulting Services will then be debited on an ongoing basis from the amount paid in advance in \$2.50 increments per minute for all remote consulting services including telephone conversations, screen share training sessions, virtual meetings, chart optimization, custom indicator creation, and trading system development.

Terms

- The Client acknowledges that there are no guarantees, warranties, or representations of any nature attached to this consulting services agreement as to the future profitability or performance of the client's trading activities or NeuroShell Trader charts, indicators, predictions, trading systems, or generated trades.
- The Client acknowledges that past performance, whether actual or indicated by historical tests of strategies, is no guarantee of future performance or success. Losses do occur in trading stocks and commodities. The risk of loss in trading can be substantial and there is a possibility that you may sustain a loss equal to or greater than your entire investment regardless of which asset class you trade; therefore, you should not invest or risk money that you cannot afford to lose.
- The Client acknowledges that Consulting Services are based on an hourly fee and not a project-based fee. Even if an initial estimate of consulting service fees was given for a project specification, additional hourly consulting fee payments above and beyond the provided initial estimate may be required to finish the project.
- The Client acknowledges that all Consulting Services will be provided remotely during regular business hours via phone, email, virtual meetings, computer screen sharing, or programming work. There will be no travel or in-person services provided as a part of this consulting services agreement.
- The Client acknowledges that there are no refunds applicable to the Consulting Services.
